# 2022 Membership Programs

### FAMILY GOLF MEMBERSHIP

*\$300 Monthly*

A Family Golf Membership includes full use of the golf course, swimming pool, and clubhouse. Memberships are considered family memberships, and privileges apply to spouse and dependent children of the member.

### SINGLE GOLF MEMBERSHIP

*\$250 Monthly*

A Single Golf Membership includes full use of the golf course, swimming pool and clubhouse for the single member only. Spouses/significant others and dependents of single golfers shall be subject to all guest fees, Twilight golf, holiday club events and use of the pool.

The Club requires a one-time initiation fee of \$1,000.00 per membership.



### YOUNG PROFESSIONAL GOLF MEMBERSHIP

*\$222.50 Monthly*

A Young Professional Golf Membership includes full use of the golf course, swimming pool, and clubhouse for a member who is under 36 years of age. Memberships are considered family memberships, and privileges apply to spouse and dependent children of the member. This pertains to the oldest spouse in the family.

### CADET GOLF MEMBERSHIP

*\$145 Monthly*

A Cadet Golf Membership includes full use of the golf course, swimming pool and clubhouse for a member who is under 30 years of age. Memberships are considered family memberships, and privileges apply to the spouse and dependent children of the member. This pertains to the oldest spouse in the family.

### SOCIAL MEMBERSHIP

*\$170 Monthly*

A Social Membership includes access to the UGCC clubhouse and swimming pool, as well as limited use of the golf course. Memberships are considered family memberships, and privileges also apply to the spouse and dependent children of the member.

Social Members may golf five (5) times per golf season. Guest green fees will be charged to social members. Twilight golf events on Friday evenings and holiday club events are also available to social members and not subject to limitation.



### FOOD AND BEVERAGE MINIMUM

Members are required to charge a minimum of \$50 for food and beverage to their accounts each month. If no charges are made, a \$50 minimum will automatically be charged to said account. Tax and gratuity are not included in calculation of the food minimum.

### NETWORKING MEMBERSHIP

*\$50 annually*

A Networking Membership includes full access to the UGCC clubhouse. The dining room, event space, and bar are all available for use by all members of the family: the member, spouse and dependent children of the member. There is no required monthly food purchase minimum. This is an excellent membership for individuals looking to network with other professionals, utilize the space for client meetings, or enjoy the dining and beverage opportunities with friends and family.
